

# Liquor Policy Rules & Regulations

Club Patrons

#### Purpose

The purpose of this police is to set forth the position of **Saxonburg Volunteer Fire Company** with regard to alcohol consumption. Our position is that if one chooses to drink alcohol at social events, one should be guided by maturity, restraint, and regard for the well-being of others.

# General

- 1. You must be at least 21 years of age to be in the bar area unless accompanied by a parent or legal guardian.
- 2. No individual under the age of 21 is permitted to purchase or consume alcoholic beverages on this premises. Any individual under the age of 21 seen purchasing or consuming alcoholic beverages will be removed from the premises and the proper authorities notified.
- 3. You must be an Active, Associate, or Social Member of the Saxonburg Volunteer Fire Company in good standing, an Active Member of another Fireman's Club, or accompanied by an Active, Associate, or Social Member of the Saxonburg Volunteer Fire Company to be in the Fireman's Club.
- 4. Proof of age will be required of any guest entering or patronizing our facilities. If you appear to be under the age of 25, you will be required to show valid identification with photograph and proof of age.
- The Club Steward and/or Bartender(s) reserve the right to refuse service for violation of any of these rules. It is the policy of the Saxonburg Volunteer Fire Company to discontinue an event if we believe individuals are becoming intoxicated or unruly. Law Enforcement will be contacted if necessary.
- 6. No private parties will be permitted in the Club area.

#### Guests

- 1. All guests must be signed in by an Active, Associate or Social Member (in good standing) of the Saxonburg Volunteer Fire Company or member of another Fireman's Club.
- 2. A member may sign in no more than six (6) persons per day.
- 3. Guests may not purchase drinks directly from the bar.
- 4. Guests, other than Active, Associate, or Social Member's spouses, may visit the Club no more than two times (2) per seven (7) day period.
- 5. Children under the age of 16 may not be in the bar if food is not being served or if no special event (e.g., Bingo, private party, meeting). When children are permitted to be in the Club, they must be out of the Club by 8:30pm on Weeknights (on school nights) and 10:30pm on other nights.



### Conduct

- 1. Use of profanity, loud, and/or abusive language, lewd or immoral gestures will not be tolerated and may be cause for ejection from the bar area or Club.
- 2. Proper attire (e.g., pants, shirts, shoes) must be worn in the Club at all times.
- 3. The Club Steward or bartender in charge reserves the right to refuse service or may cause to be removed from the premises any person who refuses to conform to these rules.
- 4. All matters of misconduct may constitute grounds for suspension and/or expulsion from the Saxonburg Volunteer Fire Company pending a review by the Board of Directors and General Body.
- 5. Members are responsible for the actions of their guests.
- 6. No illegal gambling is permitted on the Club premises.
- 7. All Club patrons shall conform to Pennsylvania State Liquor Control Board (PLCB) laws and regulations.

# Bar Area

- 1. You must be at least 21 years of age to sit at the bar.
- No one is permitted behind the bar area or in the Club Office except for official Club business (e.g., bartending, deliveries, maintenance) or as directed by the Club Steward and/or Bartender in charge.
- 3. No alcoholic beverages may be brought into or removed from the downstairs Club area by anyone except on-duty bar personnel.

#### Phones

- 1. Club phone usage will be at the discretion of the Club Steward or bartender in charge.
- 2. No long distance calls are to be made from the Club phones unless for official Club business or as directed by the Club Steward or Bartender in charge.
- 3. Phone calls *must* be taken by the member or guest requested.

#### Games/Machines

- 1. You must be at least 21 years of age to play any of the small games of chance.
- 2. You must be at least 18 year of age to play with all other games with the exception of video arcade games.
- 3. To play video arcade games, you must be tall enough to play the game without the use of a platform, chair, or other lifting device.
- 4. The Club Steward and/or Bartender in charge may suspend the rights of a member to play any games.



# NOTICE

You must be 21 years of age to be served alcoholic beverages. If you appear to be under age 25, you will be carded.

You must show a valid form of identification including age and photograph.

SVFC Club Staff has the right to refuse service to any person(s).
